Stormont Vail Health and Cotton O'Neil Preferred Lab Benefit



Stormont Vail Health and Cotton O'Neil have negotiated rates for laboratory work for State Employee Health Plan (SEHP) members. You must verbally request to use your Preferred Lab benefit and bring the ID card from your health plan identifying your membership with the State of Kansas health plan.

All Cotton O'Neil patients can have blood drawn at their own physicians office. If you do not have a Cotton O'Neil doctor, you will need to go to one of the locations listed on the back.

For Plan A

Cotton O'Neil will draw the specimens and process the lab work at the negotiated rates, and your health plan will pay the claims at 100 percent (**no deductibles, copayments or coinsurance for the lab services**). You may have a copayment for the office visit as well as deductible, copayment or coinsurance for other services performed within the same visit.

Stormont Vail Health will process the specimens for SEHP members and return the the lab reports to the ordering physician. All covered lab work processed by Stormont Vail Health for SEHP members will be processed and paid in full by your health plan.

For Plans C, J, N and Q

Cotton O'Neil will draw the specimens and process the lab work at the negotiated rates. Your health plan provider will notify you of the amount you owe until your deductible is met. This amount will reflect the negotiated rate. Your office visit or other services may also be applied to your deductible until that deductible is met. Once you have met your deductible, all covered lab services are paid at 100 percent of the allowable charge.

Stormont Vail Health will process the specimens for SEHP members and return the lab reports to the ordering physician. All covered lab work processed by Stormont Vail Health for SEHP members will be processed and applied to your deductible or paid in full by your health plan.
