### **Purpose**

To provide a health service by administering COVID-19 vaccine to individuals in accordance with the tier structure set forth by the emergency management team.

### **Qualifications**

To perform this position successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below or in attached documentation are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Licensure of MD, DO, APRN, PA, RN, LPN, PharmD, Pharmacy Tech
- Must have either an active license or a license that hasn't been inactive for greater than five years.
- Healthcare related licenses from other states are valid to allow the individual to provide services in Kansas

#### **Education/Experience**

Have the proper certification and training to administer vaccinations to patients.

#### **Language Ability**

Ability to read and speak effectively with customers and staff is required.

#### **Math Ability**

Ability to perform mathematical calculations related to medication administrations and equipment calibration. Ability to work with mathematical concepts such as probability and statistical inference, and fundamentals of plane and solid geometry and trigonometry. Ability to apply concepts such as fractions, percentages, rations and proportions to practical situations.

#### **Reasoning Ability**

Ability to apply common sense understanding to carry out instructions furnished in written, oral, or diagram form.

# **Computer Skills**

Willingness to learn necessary computer skills.

- Attend new volunteer general orientation given by Volunteer Services.
- Attend unit specific service meetings, as scheduled and as needed.
- Complete the annual volunteer education module given by Volunteer Services.
- Attend any additional training provided by Volunteer Services and/or unit specific.

- Comply with all department policies and procedures.
- Upon reporting to the area, receive instruction from supervisor or designated staff regarding specific activities needing to be completed.

Is knowledgeable and acts in accordance of the 10 tenets of the Small Moments program.

#### **Work Environment**

Works indoors in a well-lighted, air-conditioned/heated environment.

# **Physical Demands**

While performing the duties of this position, the volunteer is regularly required to stand or sit during the majority of the scheduled shift. The volunteer is required to bend forward by bending the spine at the waist, and kneel, or crouch. Must be able to travel to the screening location. No lifting is required.

Talking, seeing and hearing are essential to perform the duties. The vision requirements include the ability to adjust focus.
